MESSAGE FROM LEADERSHIP

Dear Friend,

This past year, Pathfinders continued to increase the depth and breadth of resources we offer youth and young adults facing homelessness, sexual exploitation and trafficking, crisis and trauma.

Our service numbers have returned to those that we saw pre-pandemic. More young people are experiencing homelessness and housing insecurity – a winter heating bill, car repair or medical bill often leads to a loss of current housing.

We hear from the broader community that homelessness seems like too difficult of a problem to solve. At Pathfinders, **we know there's a proven way to resolve it – provide housing.** Period.

And that's exactly what Pathfinders intends to keep doing.

Last fall, I shared that Milwaukee was selected by the U.S. Department of Housing and Urban Development (HUD) to receive more than \$3 million for two years of funding through the Youth Homelessness Demonstration Program.



The process included deep involvement of youth and young adults with lived homelessness expertise, along with collaboration between Pathfinders' leadership, the City of Milwaukee, Milwaukee's Continuum of Care, Walker's Point Youth & Family Center and many, many others.

It's a huge accomplishment to be selected the first time we applied. And there's a lot of work to do in the coming year to move young people off the community's waitlist and into safe, stable housing.

This also marks the first major investment specifically addressing youth homelessness in Milwaukee.

By investing in both housing and upstream homelessness prevention, we ensure greater safety and stabilization for all young people both today and throughout their lifetimes.

We ask for your continued support and partnership as we continue to make significant investments in this important work.

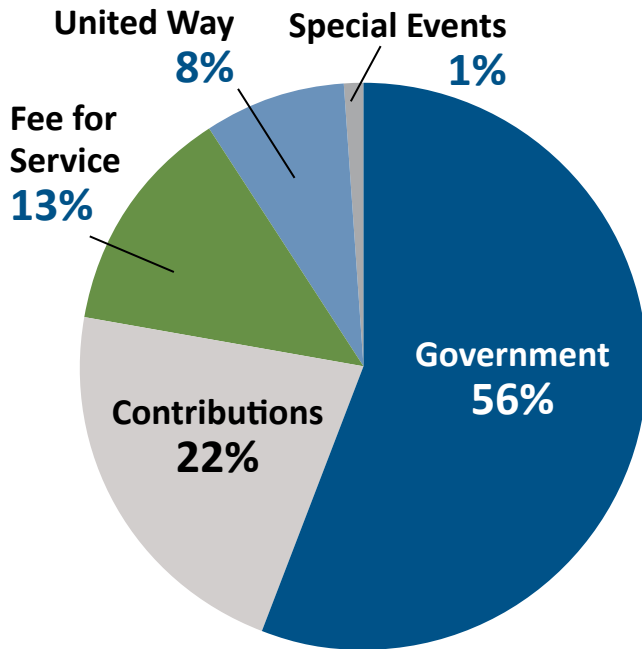

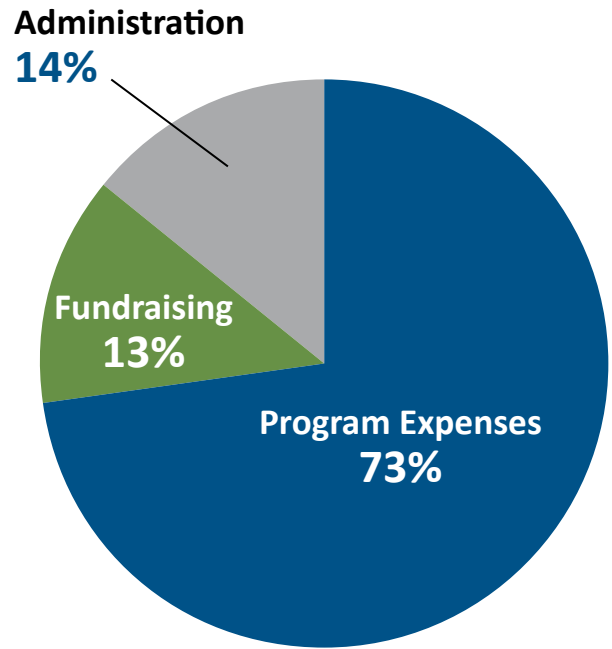

OUR IMPACT

In 2023, Pathfinders helped young people build their:

STABILITY

- 100% of youth who accessed Pathfinders' shelter avoided homelessness and 100% exited to safe and sustainable living environments.
- 95% of young adults in Supported Housing programs were housed; the other 5% continue to receive support.

SAFETY

- 100% of youth who accessed anti-violence services developed safety plans to reduce their risk of sexual exploitation.
- 100% of youth in the Drop-In Center had their basic needs met (food, clothing, hygiene, safe social spaces).

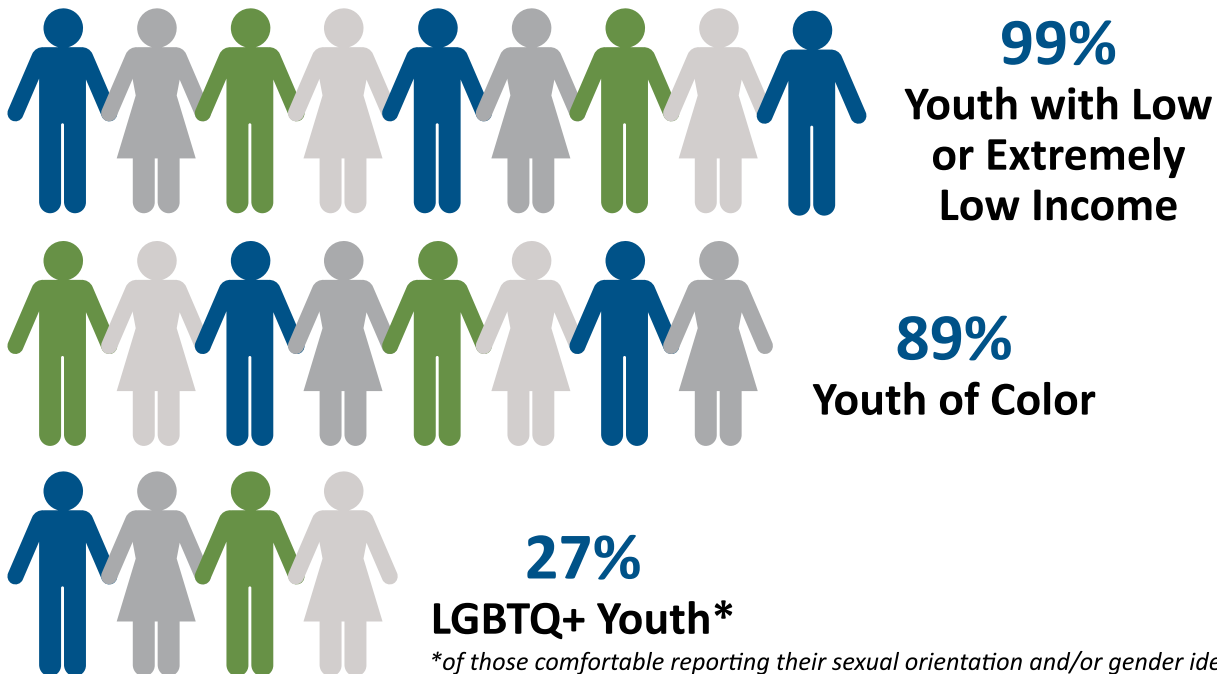
WELL-BEING
