MESSAGE FROM LEADERSHIP

Dear Friend,

Last year was again filled with challenges and successes. We saw funding decreases to some of the services we offer youth, young adults and young families, and growth in others. **Two things remained constant: young people continue to experience homelessness and housing instability and you helped when we asked.**

We had success with two strategic efforts in 2025: reducing the number of young people on Milwaukee's housing waitlist and preventing episodes of homelessness before they occur. Note: the highlights below only represent the expansion.

- **55 young people and their 19 minor children moved off of Milwaukee's housing waitlist into safe, stable homes**
- **34 additional youth and their 46 family members avoided homelessness by receiving a crisis stipend and case management**

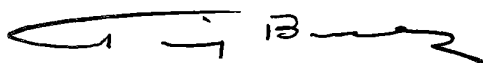
Our plan aims to decrease the demand for lifelong need and immediate crisis interventions by justice, healthcare and other systems, and to increase safety, stability and well-being. How? We're mobilizing input, expertise and resources from youth, landlords, philanthropic, government, community and national partners.

Instead of building a facility, we used new funding to expand upon what we do best – provide housing, crisis stipends and wraparound support to youth, young adults and young families in need.

We said last year that we expect to see gains and losses to programs for the coming few years due to volatile and uncertain funding, in addition to inflation and tax code changes.

Your ongoing partnership and flexible financial support ensure we can remain fiscally sound and available all year long to Milwaukee's most vulnerable young people.

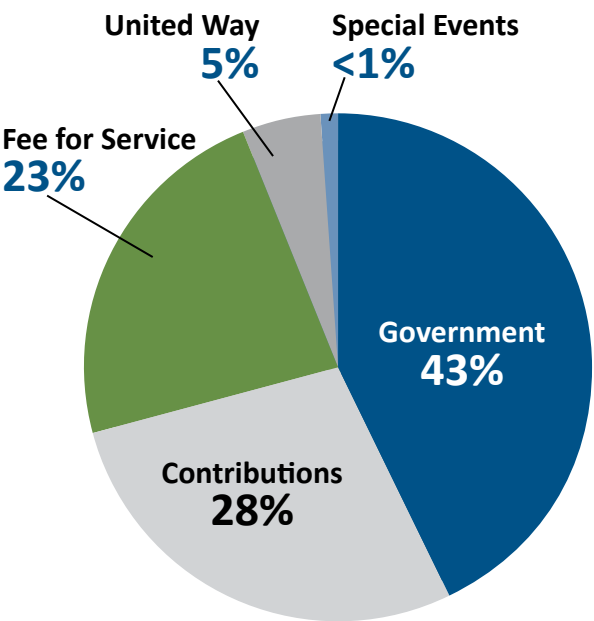

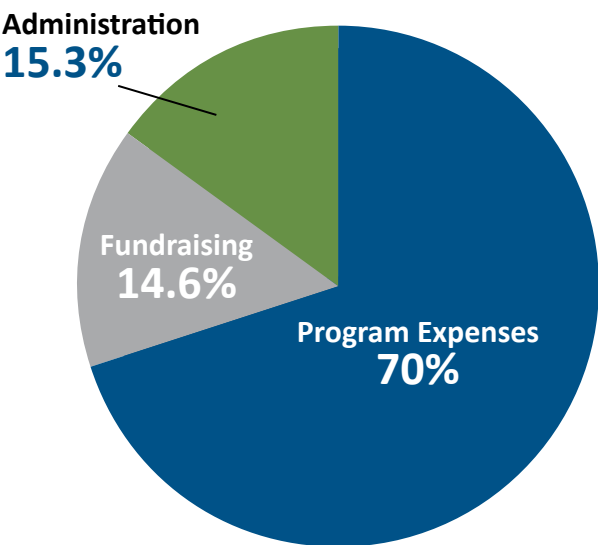
